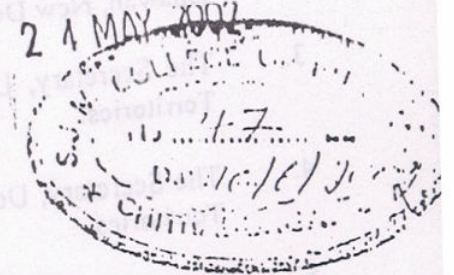


It is requested that careful proof reading be done before printing. It is further informed that -

- ii) Resolution No.69/PCI/1317 to 69/PCI/1348 pertain to Degree in pharmacy both in English & Hindi.


