Feedback Obtained

Student, Alumni and Parents feedback is collected at the end of the academic year. The student's feedback on teachers, overall facilities and programme is collected using respective set of questionnaire. The students are required to give feedback on teachers about the extent of syllabus covered, punctuality, quality of teaching. The feedback on each teacher is analyzed by a committee of members and is reported to the Principal. The principal conducts a meeting with HODs and suitable measures are taken to improve quality of teachinglearning activity based on the feedback analysis report. On completion of course the students are required to give feedback on facilities, programme and overall quality of teaching. The students rate on a scale of regarding extent of course coverage and weather the programme objective have been achieved, facilities at the institution and hostel, placement support rendered, teaching methods, professionalism of teachers and learning outcome. The feedback is anlayzed and suitable measures are initiated by the management to improve facilities and programme outcome. Parents and alumni feedback is collected during their visit to institution.
